To enroll your child in SkyMiles, please complete both this enrollment form with your child's information and the parent/legal guardian consent form. Be sure to use the same name as it appears on your child's passport or government ID.

To submit, please return a fully completed, signed copy of the SkyMiles program application and parent/legal guardian consent forms by email or fax to:

Once the enrollment has been processed, you will receive an email with your child's confirmation and SkyMiles number. Note, as a new member, your child can receive mileage credit for flights taken no more than 30 days prior to enrollment. You may submit that request at [delta.com/mileagecredit](http://delta.com/mileagecredit) with their SkyMiles and ticket numbers. If your child's SkyMiles number is not provided on future reservations, retroactive mileage credit can be requested using the same link up to nine months from the date of your child's flight.
